

## 100      Confirmation of Minutes

M. Robinson Sivyer advised the sentence "M. Robinson-Sivyer advised he would speak to the local primary schools to see if they would like to get involved in a nativity play at the light switch on" was incorrect as he was contacting the schools regarding singing at the event, not a nativity.

**RESOLVED** that the minutes of the Festivities Committee meeting held on Monday 7<sup>th</sup>

April 2014 be amended and confirmed as a correct record.

### **Matters Arising**

M. Skinner advised that Ali's Barbers, the Post Office, Plummer Parsons and the Chiropodists in North Street had all agreed to have a wall mounted Christmas tree on the outside of their premises. The Committee Clerk advised that the electrical contractor, Guy Osborne, had given the following information about fixing the Christmas trees to buildings and obtaining the electricity for the lights on the trees. There were three options for this:

- a) A suitable wall mounted external 3pin 13amp socket.
- b) Access to an existing external feed to a shop sign that can be tapped into.
- c) An internal 3pin 13amp socket near to the tree location that may be able to pass through a gap in the window frame or may require a small 10mm diameter hole drilling through a window frame/wall for the supply cable to pass through.

It was agreed that if a fifth shop requested a tree the extra £100 for this could be taken out of the festivities budget.

### **Christmas Lights**

J. Cullen advised he had spoken to the musical department at Hailsham Community College and it would be possible to organise some singing and possibly a band for the switch on event.

The Rotary Club confirmed that Santa and his sleigh would be present at the switch on from 4.45 pm – 5.30 pm; J. Bentley stated she would try and organise some sweets for Santa to give to the children.

D. Sinden suggested St Mary's Church could be open for the switch on, between 4.30 pm and 5.30 pm. She advised she would speak to her colleagues for ideas of what could take place at the Church at this time.

J. Bentley and K. Moralee will approach Dominos regarding the design a pizza competition.

### **Christmas Market**

M. Caira advised he will present a proposal from Hailsham Forward at the next festivities meeting, but the general idea will be to have 40/50 stalls at the market.

### **Town Fete**

The programme sponsored by BMW in Hailsham will be finalised shortly.

A bouncy castle assault course has been located and will be booked shortly. It was confirmed East Sussex Fire Service will be present at the event with a fire engine and with the volunteers organising badge making for the children. There will be a "challenge cup" between the houses of the college, plus face painting, nail painting and guess the weight of the cake.

J. Cullen advised that the times of the Fete have been agreed as 11.00 am to 3.00 pm.

Charities will need to be set up by 10.00 am and they can have access to the site from 8.00 am.

D. Sinden suggested St Mary's Church could open at the time of the Bonfire Society fireworks event on the 18<sup>th</sup> October, offering hot chocolate before the start of the procession.

### **Charter Market**

23 food stalls so far had confirmed they would be attending the event.

At the evening event there will be stalls selling red and white wine, two Sussex brewery stalls – Harvey and Dark Star and a local Sussex cider stall from Norman Hunt in Battle, plus bread from Truffles in the High Street and cheeses and meats.

The Committee were advised that a number of tables and chairs will be available to place in Vicarage Field with some more available to rent, if necessary. Members were asked what numbers should be catered for, for the above, and after some discussion it was agreed to cater for 100 people.

The Committee Clerk advised that a jazz band had been booked for the evening but some further entertainment was required for in between. J. Cullen advised he will approach some of the pupils from the College to sing at the event.

The Committee Clerk advised she had contacted the 1940's singers "Swingtime Sweethearts" and it was decided they could sing from approximately 4.30 pm to 5.30 pm.

It was requested the PCSO's are contacted and asked to attend the evening event.

Members agreed to place an advert for the Charter Market in "What's On" magazine and also the Hailsham Lions programme.
