104 <u>Hailsham Live Event</u>

- P. Gibson updated the Committee on the progress of the Hailsham Live event
 - A full event management plan has been submitted to Wealden District Council along with a security plan
 - Licences are due to be obtained
 - The Lord Lieutenant is due to attend the event but if he cannot his Deputy will attend
 - The East Sussex High Sherriff will also attend the event
 - The MP Nus Ghani will be attending the event
 - Katy Bourne from Sussex Police has been invited
 - The Cattle Market owners have agreed to allow parking on the Cattle Market site
 - P. Gibson is applying for CIC status for Hailsham Live this is in progress as the form needs to be re-submitted as the wording needs to be changed
 - Hailsham Voices, Sussex Stompers and Wealden Brass all due to be involved in the event
 - P. Gibson is meeting with the local schools to see if they wish to be involved in the event
 - The UK's Tribute to "Pink" and Rockitmen are being considered for the two bands for the evening event
 - The event will be announced to the public in Friday 10th January

105 **Street Markets**

M. Caira advised that there had been a good turnout for the Christmas market. The pitch fees have now been waived for the traders, for January, February and March. M. Caira has also received enquires from 4 new traders, since Christmas, who potentially may wish to trade at the market.

106 **Hailsham Forward**

M. Caira reported that 60 people had attended the Chamber of Commerce Business Breakfast in December.

The Committee agreed that the event had gone well. It was further agreed that the profile of the Find the Elf competition and the fancy dress competition could be raised this year. Councillors K. Nicholls and A. Ricketts volunteered to cover the primary and secondary schools between them to advertise the competitions.

B. Funnell stated that Hailsham Rotary wish to continue organising the Santa and sleigh for the event.

Members were informed that the surplus sweets had been given to the foodbank and Youth Café.

R. Piggott reported that the Bonfire Society had had a successful day at the event, D. Sinden also reported that the Church had received a good number of visitors including some new residents to Hailsham, and the concert by Wealden Brass had been a success.

The Committee discussed the date of the Christmas market 2020 and agreed on Saturday 12th December, providing the Farmer's Market are agreeable to that date.
