RESOLVED that the FBRS Committee recommend that the council award or not award the following community organisation annual grants. Reasons for not awarding are noted for each organisations:

Diplocks Community Trust - Awarded £400.00

Bonfire Society - Awarded £2,500.00

Mediation Plus – The Service doesn't cater to Hailsham – Suggest to larger Local Authorities for funding.

Hailsham Active – Awarded £500.00

Cedar Residents Association – Requested 100% funding – they receive a service charge from residents.

Summerheath Hall – Awarded £500.00

Hailsham Healthy Living Club Committee - Awarded £500.00

Hailsham Allotment Society – Awarded £400.00

Citizen Advice Bureau (Hailsham) - Awarded £13,300.00

Hailsham Cricket Club – Awarded £200.00

SASBAH - Awarded £300.00

Wealden Writers – Does not meet the grant criteria

Christchurch Youth Group – HTC have other funding priorities for Youth, felt that the church had other opportunities for funding.

Environment Hailsham – Awarded £4,000.00

Hailsham Foodbank - Awarded £500.00

East Sussex Association of Blind & Partially Sighted People - Awarded £200.00

Hailsham Choral Society - Awarded £300.00

Hailsham Theatres – Awarded £500.00
