223 Confirmation of Minutes

It was agreed all updates would be discussed throughout the meeting

225 Street Markets

M. Caira advised that as of this coming Saturday all traders are allowed to return to the street markets, however some traders are not ready to return yet as they do not feel comfortable trading in the current environment.

Traders have been offered a free pitch until restrictions are lifted and the Committee were asked whether they were in favour of continuing the offer of free pitches, which would then be reviewed again in June.

It was suggested that the new businesses in the Town could be invited to trade at the street markets and M. Caira confirmed he would look into this

226 <u>Hailsham Forward</u>

M. Caira advised he has spoken to the Chamber of Commerce and they are hoping to resume their business breakfasts in the summer and are still working through a number of projects.

227 <u>Hailsham Live Event 2021</u>

P. Gibson advised that the road closure application has been submitted for the event.

The event is now planned to be held in Vicarage Field and the car park by Freedom Leisure and twenty stalls have been booked.

A meeting has been arranged with Wealden Council towards the end of the month to consider the number of stalls which may be allowed, after restrictions are due to be lifted on June 21st. P. Gibson advised he has arranged children's rides, a small stage in the Town Centre for live entertainment, morris dancers, and a brass band. There will be only one food vendor on site, to ensure that business is not taken away from local food shops and takeaways.

Members were advised that even if restrictions are completely lifted on 21st June those attending the event will still be encouraged to hand sanitise and social distance.

Councillor N. Coltman thanked P. Gibson for his perseverance in trying to organise the event, which had to be cancelled last year.

- B. Pratt advised that this day will also be the Saturday of the Farmers' Market and he suggested holding discussions to link the two events.
- P. Gibson advised that he had spoken to the owner of the Cattle Market who has confirmed that some of the area of the Cattle Market can be used for car parking for the event.

228 **Community Forum**

J. Seale reported she is trying to organise meetings again in the Church Hall after 21st June and has contacted members of the Community Forum to see how they feel about

meeting physically again or whether they would rather continue to meet remotely at the moment.

D. Sinden advised she would check to get confirmation but she thought it was unlikely that the Church would be open for meetings again before September.

229 **Bonfire Society**

D. Cottingham advised that the Bonfire Society continue to plan the event in the hope that this will go ahead in October

230 <u>Lions Fun Day</u>

G. Constable confirmed that the Lions Bookshop will re-open on Monday.

The Fun Day event is planned to go ahead in July.

The Lions also plan to attend a street market shortly.

231 <u>Hailsham Festival</u>

T. Biggin was unable to attend the meeting but had sent the following update:

Plans for our 2021 blended festival are progressing well. If circumstances permit we hope to hold about 10 live events as well as virtual ones during the festival fortnight (Sept 4-18)

The festival finale will comprise a showcase concert of String, our community musical. A dozen local solo singers will be joined by the acclaimed poet, Roger McGough (BBC Poetry Please) who will be the narrator. A Hailsham nostalgia day is being created around the show.

232 Hailsham Farmers' Market

B. Pratt advised he has arranged a meeting with McCarthy and Stone, the developers who are purchasing the Cattle Market site.

He further reported that he was concerned that the Cattle Market will be moved to an out of town site and that this won't be a viable trading site.

Hailsham FM

- N. Mullery advised Hailsham FM have been interviewing shop traders. M. Caira confirmed that Hailsham FM can carry out live broadcasting at the street markets and N. Mullery stated he would email M. Caira with dates.
- B. Pratt thanked Hailsham FM for their support at the Farmers' Market.

234 Hailsham Parish Church

D. Sinden advised that "in person" services had begun in mid March with social distancing measures in place.

Due to the recent sad passing of Prince Philip, D. Sinden advised that the Church would be open from 11.00 am to 12.30 pm on Monday and Tuesday for anyone who wished to sign the Book of Condolences. There would also be a Service of Commemoration on Sunday at 6.00 pm, for 45 minutes.

D. Sinden further reported that the Church is planning to open to external groups in September.

K. Giddings advised that the Remembrance Day Sub Committee had met for the first time just before the Communities Meeting and the notes of the meeting would be circulated to the Committee.

Hailsham FM confirmed they would provide the PA system for the day and would also broadcast the event live on the day.
