

TITLE OF REPORT: To consider a request to allow permission for Lightening Fibre to lay a cable from the footpath in Western Road to the Cricket Pavilion

BACKGROUND:

Lightning Fibre have contacted the Council stating that they would like to provide a full-fibre broadband connection into the Hailsham Cricket Club, free of charge, "as part of Lightning Fibre's commitment to the local community".

They originally requested permission to install through the grass and new pathway, making good afterwards as part of the project.

The Deputy Town Clerk has advised that this method of installing through the new pathway will not be possible, and that the only possible way forward is for the Cricket Club to arrange to mole under the path under Lightening Fibre's direction.

This method has now been agreed and Lightening Fibre have assured that there will be no damage to the new footpath at Western Road

They are now seeking a moling contractor and have requested permission to complete the install based on them moling underneath the path

FINANCIAL IMPLICATIONS:

There will be no cost to the Council
