TABLE OF FEES – 1ST APRIL 2026

INTERMENTS

The fee payments and sums set out below apply:

Column (1) Parishioner: Where the person to be interred or in respect of whom the right is granted, is an inhabitant or parishioner of the parish of Hailsham, for any 5 years during the preceding 10 years may be buried as a parishioner and if the deceased's spouse had previously been buried in the cemetery as a parishioner, then the deceased should also be considered as a parishioner.

Column (2) Non-parishioner: Persons were living outside the parish.

The fees apply where the interment is made between the hours of 10.00am and 3.00pm, Monday to Friday.

The fees for interment are inclusive of grave digging.

No charge is made for the interment of a stillborn child or of a child whose age at the time of death did not exceed one year.

EXCLUSIVE RIGHTS OF BURIAL

For the exclusive right of burial in an earthen grave for a period not exceeding 75 years

(i) Double or single depth grave 7 feet x 3 feet	679.00	1920.00
(ii) Child's grave (whose age at time of death exceeded 1 year but did not exceed 12 years)	239.00	679.00
(iii) Cremation plot 3 feet 5 inches x 2 feet 6 inches	478.00	1,078.00

For every adult interment after the first in such graves a further period is permitted of 14 years after the date of such interment.

Pre-purchase of a burial plot is not permitted except by family members of a deceased person **AT THE TIME OF THE INTERMENT ONLY**
